The HAWC website offers a lot of new information. On our site, public housing residents will be able to download forms and applications for friends and family as well as this newsletter. In the very near future, you will be able to apply online and check your current balances due. Section 8 residents will be able to download recertification information

as well as other forms.

Change in Income Reporting by Tyra Harris

We are having an increasing problem with our residents failing to report income changes. If you are a Public Housing resident, you are required by your lease agreement to provide the Housing Authority of Walker County with information about your job, your income and the people living in your unit

You are required to report any changes in income or household composition

within 10 calendar days of the change. You must submit changes in writing with verifying documentation along with the completion of the "CHANGE OF INCOME OR CIRCUMSTANCES FORM" which will initiate an interim review if needed. Calling the office is not acceptable reporting of changes in your income or family composition.

If you fail to report changes in household composition,

income, assets, or student status within 10 calendar days of the change, your assistance may be immediately terminated. You may also be charged retroactively to the date the change should have been reported. If there is retro rent, you will be required to pay that amount or be evicted and even prosecuted for fraud. So please report changes. This form will be available on our website soon.

General Housekeeping

As you know, the key to maintaining a clean and attractive property is effort by the residents. There are a few general housekeeping issues we would like to go over with you in hopes of improving our wonderful communities.

*Please make sure you return you garbage can on pick-up days (we charge if we return it)

- *Do not pour grease or dump food items outside of your apartments (lease violation) *Keep your yards (front and back) debris free and clean
- *Do not store dangerous items behind your apartment
- *Please remove any inoperable vehicles from the premises

*Do not hang anything on windows other than the blinds provided.

Please pay special attention to these items as they will assist us and you in keeping your community clean. If you see anyone not doing their part, please let us know and we will address the matter with those individuals.

SECTION 8 (HCV) By LYNN JETTON

What is the HCV Section 8 Program?

Section 8 is a housing assistance program funded by the United States Department of Housing and Urban Development (HUD). The purpose of the Section 8 Program is to provide rental assistance to eligible lowincome families.

Section 8 is different from other subsidized housing programs in that Section 8 allows the participant to pick from privately owned houses, mobile home and apartments in Walker County.

Each voucher holder has the freedom of choice in location and is encouraged to locate suitable housing. Once suitable housing is found, the apartment, house or mobile home is inspected to ensure that all housing codes and standards are met. If all require-

ments are met, then part of the rent is paid by the Section 8 Program each month as long as income qualifications and Section 8 rules and regulations are met.

Applications are currently being accepted on Wednesday and Thursday, 8:30 a.m. to 3:00 p.m. until further notice.
