We currently just completed the bathroom remodeling at James Baird and Howard Brown apartments. This consisted of replacing tubs and sinks/vanities as well as replacing the upstairs flooring throughout. Additionally, we replaced all entry door hardware to a master core system at all housing communities.

We are currently in the planning stages for front and rear storm door replacements at the James R. Baird and Howard R. Brown complexes.

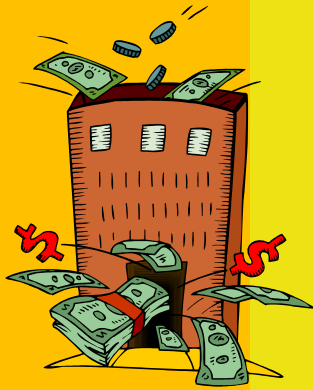
** Please keep the office updated with current cell phone numbers and email addresses. We will be issuing alerts and other notifications via texts and email in the future. Alerts include but*

**Please be reminded that there is a board approved CURFEW policy within this organization. Anyone under 18 must not be*

outside on the premises between the hours of 10:30pm-6:00am without a lease holding adult. This policy has not be adhered to recently and Dora PD will be monitoring frequently. There are a lot of issue with adults congregating in certain areas and Dora PD will also be investigating these issues as well.

Change in Income Reporting By Lynn Jetton



We are having an increasing problem with our residents failing to report income changes. If you are a Public Housing resident, you are required by your lease agreement to provide the Housing Authority of Walker County with information about your job, your income and the people living in your unit.

You are required to report any changes in income or household composition

within 10 calendar days of the change. You must submit changes in writing with verifying documentation along with the completion of the "CHANGE OF INCOME OR CIRCUMSTANCES FORM" which will initiate an interim review if needed. Calling the office is not acceptable reporting of changes in your income or family composition.

If you fail to report changes in household composition,

income, assets, or student status within 10 calendar days of the change, your assistance may be immediately terminated. You may also be charged retroactively to the date the change should have been reported. If there is retro rent, you will be required to pay that amount or be evicted and even prosecuted for fraud. So please report changes. This form will be available on our website soon.

General Property Information

As you know, the key to maintaining a clean and attractive property is effort by the residents. There are a few general housekeeping issues we would like to go over with you in hopes of improving our wonderful communities.

**Please do not store inoperable vehicles on HAWC premises. This includes flat tires. These vehicles will be subject to towing.*

** Please return your garbage can to the back side of your apartment after the garbage run.*

** Please pick up any trash in and around your yard to avoid charges.*

** If you have a pet, please go through the proper procedure as specified in your lease.*

** Watch your children carefully as they ride bicycles in and*

around parked cars. You will assume the liability for someone else's damage.

** Do not store things outside the back of your apartment such as aluminum cans.*

**Do not pour or dump food leftovers near the perimeter of the woods.*

**Please make sure your garbage is bagged before placing in your can.*

DORA POLICE DEPARTMENT

Recently there have been several calls to the management office to report a variety of issues. Residents need to call their local law enforcement agency (Dora Police Department 205-648-9110 and Oakman Police Department (for Oakman Residents) 205-622-3200) for issues that are not related to the property itself or problems within the lease. If you suspect any illegal or suspicious activity, please notify the

police department as well as the management office. If you personally witness a crime or are a party to a crime please notice the Police Department at your community. Additionally, please be aware that the HAWC office is in frequent contact with these law enforcement agencies and is notified of calls for service to our apart-

ments and will address these concerns with the affected resident as needed.
